## RECOGNITION OF ACHIEVEMENTS

#### **BUS DRIVERS AND BUS ATTENDANTS AGREEMENT**

The Board entered into an agreement with Teamsters Local 215 for wages and benefits for school district bus drivers and bus attendants beginning January 1, 2020 through December 31, 2021.

#### SCHOOL RESOURCE OFFICER AGREEMENT

The Board renewed the school resource officer memorandum of understanding for the school year with the City of Mt. Vernon with automatic one-year renewal terms.
