SCHOOL YEAR CALENDARS

The Board accepted the recommendation from the Superintendent to nonrenew the nonpermanent teacher contracts of Katie Dausman, Erica Thomas, Sarah Wellmeier, and Brittney Yelton at the close of the 2009-10 school year with the understanding that these honorable nonrenewals result from lack of enrollment and/or budgetary limitations.

SEMIPERMANENT TEACHER CONTRACT CANCELLATION/REDUCTION

The Board accepted the recommendation from the Superintendent to cancel the semipermanent teacher contracts of Kristine Deig, Lisa Koester, Scott LaMar, Jennifer Mesker, Regina Russell, Heidi Slavkin, Mary Schmitt, Trudi Weihrauch, and Amanda Wilson effective at the close of the 2009-10 school year and reduce

the semipermanent teacher contracts of Erin Mullis and Cheryl Weber to part-time status beginning with the 2010-11 school year with the understanding that these cancellations and reductions in status are honorable and are due to lack of enrollment and/or budgetary limitations.

PERMANENT TEACHER CONTRACT CANCELLATION

The Board accepted the recommendation from the Superintendent to cancel the permanent teacher contract of Cory Brunson effective at the close of the 2009-10 school year with the understanding that this cancellation is honorable and is due to lack of enrollment and/or budgetary limitations.
